- Request a quote for the program of interest. The program donations quoted on the website are estimates only.
- Once you receive an official quote from Bright Light Volunteers, you and your group members have 30 days to enroll.

• ~8 MONTHS PRIOR TO DEPARTURE

- Enroll your group!
- Each individual member of your group must complete the attached Bright Light Volunteers Enrollment Packet.
- All enrollment packets should be returned via email to enroll@brightlightvolunteers.org
 8-9 months prior to travel.
- Each member of your group must submit a non-refundable, \$500 deposit along with their enrollment packet.

How to make payments:

- Online: Individual participants may visit the Bright Light Volunteers website and click the DONATE button. Be sure to include the participant's name, school or organizational affiliation, and the program dates and destination. Debit cards are the prefered method of payment. Credit cards may be accepted for an additional fee.
- 2. <u>Mail</u>: Individual participants may write and mail checks or money orders to Bright Light Volunteers, International. Be sure to include the participant's name, school or organizational affiliation, and the program destination.
- 3. <u>In Person</u>: Individual participants may pay their group's program coordinator with cash, check, or money order.
- Once your Enrollment Packet and non-refundable, \$500 deposits have been received, your group is officially enrolled.

Agreement

I understand that my participation in a Bright Light Volunteers service program is an opportunity for me to broaden my understanding of the world. Through my participation I will continue to develop cross-cultural awareness and understanding, and I will act to promote positive change in our global community. I understand the following rules and expectations of this program:

Rules and Expectations

- 1. Participant agrees to adhere, and abide by, all of Bright Light Volunteers' policies and procedures.
- 2. Participants are to conduct themselves in a manner that does not disrupt or interfere with the program or jeopardize the safety of self or others.
- 3. Participant agrees to abide by all the laws, rules, regulations and policies of the host country, community or any organization involved with this program.
- 4. Participant agrees and understands that their participation in this program may be terminated at any time if they should engage in conduct that is harmful to themselves or others, jeopardizes the success of the program or violates the rules and regulations of Bright Light Volunteers and its community partners.
- 5. All participants must stay with the group. Wandering off without permission from both the Onsite Coordinator and the Program Leader will result in dismissal from the program and the participant will be sent home at their own expense.
- 6. Participants will respect the culture and belief systems of the host community.
- 7. Participant agrees and understands that if they are terminated from the program that they would be fully responsible for any and all costs connected to returning them to their point of origin. Furthermore, they agree and understand that they will not be eligible for any program refunds due to the termination.



Commitment of Participants

I understand that an enjoyable and worthwhile program depends on my active and enthusiastic participation. I will follow all the rules and understand that breaking these rules will result in dismissal from the program and that I will be sent home at my own expense. RELEASE OF LIABILITY FOR INTERNATIONAL TRAVEL

I, the person signing this Release Agreement, now voluntarily enters into this Release Agreement ("Release") with Bright Light Volunteers. Bright Light Volunteers is a not for profit, charitable organization formed under Section 501(c)3 of the US I.R.C. that is committed to international student volunteering, uniting people and cultures through positive, sustainable change. We bring people together for the better because we believe we can teach and learn from one another We are dedicated the mission "bringing the world closer together, and making the world a brighter place." Bright Light Volunteers seeks to reach these goals through its programs in different countries throughout the world.

In order for Bright Light Volunteers to permit me to participate in the Program, I enter into this Agreement. In consideration of Bright Light Volunteers allowing me to participate in the Program, which I agree is full and adequate consideration, I now enter into this Release Agreement, fully intending that I will be legally bound by it.

I now agree on behalf of myself and my heirs, assigns, personal representative, and estate to expressly release and defend, discharge, and indemnify Bright Light Volunteers (its employees, officers, directors, agents, board members, volunteers, affiliates [including Bethel University], subsidiaries and assigns) for and from any personal injury or property damage related to or occurring as the result of my participation in the Program, or while traveling to and from the Program site. I further represent that I am 18 years of age or older, have the authority to execute this Agreement, and that I am not under guardianship, conservatorship or any other legal authority.

I recognize that the Program involves risks, both known and inherent risks and unknown or unanticipated risks. My participation in the Program could result in damage to or loss of my personal property and serious physical or emotional injury to me, up to and including death. These risks include but are not limited to risks involved in air and ground transportation, differences in living conditions, diet, water quality, pollution, climate, political stability, and crime control. I will experience a different cultural environment while traveling in the course of the Program, which may include different cultural stereotypes or expectations, sexual harassment, or other uncomfortable situations. While representatives of Bright Light Volunteers will make reasonable efforts under the circumstances to respond to any of my health care and personal safety needs, I understand that any care or protection provided may differ significantly from care or protection available in the United States. Other risks are described by the U.S. Department of State at: http://travel.state.gov/travel/cis_pa_tw/cis/cis_1127.html.

All of these risks are listed as examples and I understand that listing these examples is not a limitation of the potential hazards. Bright Light Volunteers has not attempted to include an exhaustive list of the risks which I may encounter while participating in the Program. Knowing this, it is my intention for this Release to be interpreted as broadly as the law permits in favor of Bright Light Volunteers regardless of whether any particular risk which may result in an injury to me is specifically listed in this agreement.

If Bright Light Volunteers or anyone acting on its behalf incurs attorney's fees and costs to enforce this agreement, I agree to pay those attorney fees, and to indemnify them from all such fees and costs. If any provision is found to be unenforceable or invalid, all of the other terms and provisions of this Release shall remain in full force and effect.

I certify that I have insurance to cover injury or damage I may cause or suffer while participating in the Program, or else I agree to bear the cost of such injury or damage myself. I further certify that I have no medical, physical, emotional conditions, which could interfere with or compromise my safety during the course of the program, or else I am willing to assume and bear the cost of all risks that may be created directly or indirectly by any such conditions.

This Release is a contract with legal consequences. By signing this document, I acknowledge that if personal injury or property damage occurs during participation in this Program, I may be found by a court of law to have waived my rights and any rights of my heirs, assigns, personal representative, and estate to maintain a lawsuit against Bright Light Volunteers on the basis of the claims I am releasing. I have had sufficient opportunity to read this document in its entirety. I understand this Release Agreement and I agree to be bound by its terms.

Bright Light Volunteers is a not for profit, charitable organization formed under Section 501(c)(3) of the US I.R.C. that is committed to international student volunteering, uniting people and cultures through positive, sustainable change. We bring people together for the better because we believe we can teach and learn from one another. We are dedicated the mission "bringing the world closer together, and making the world a brighter place." Each participant is required to read and sign this Drug and Alcohol Policy before participating in a program.

As a participant in a Bright Light service program, I understand that I am serving as an ambassador for Bright Light and for our home community. Therefore, I am expected to abide by the laws, regulations, and customs of the host country, community, institution, and program. I will conduct myself in a responsible and mature manner at all times.

Alcohol Use

Although there may be no minimum drinking age in the host country, the customs regarding alcohol use may be very different from the ones in the United States. I am aware of the following circumstances that might tempt me to misuse alcohol while abroad: a mistaken impression of how alcohol is used in your new surroundings; cheaper costs in some countries; a lower minimum drinking age; more lenient laws against drunkenness; or a desire to experiment or fit in.

However, during my orientation I was well informed that alcohol misuse and abuse is not acceptable anywhere in the world and will not be tolerated on a Bright Light Volunteers service program. Violation of local laws and/or BLV policies related to alcohol use will result in:

- Parental notification and university/school notification
- Possible dismissal from the program, at participant's expense

Drug Use

Bright Light has a zero-tolerance policy regarding the possession, use, manufacture, production, sale, exchange or distribution of illegal drugs by participants in the Bright Light service programs, including, but not limited to, the BU Global Service Learning Program. Violation of this policy will result in:

- Parental and university/school notification
- Immediate dismissal from the program, at participant's expense
- Academic withdrawal from the University for the semester in progress, if applicable



NOTE: Each year several thousand Americans are arrested overseas. Many of the arrests are on drug-related charges. If you choose to use illegal drugs abroad, there is very little that anyone at

Bright Light Volunteers, our educational partner, Bethel University, or the US Government can do to help you if you are arrested.

You are operating under the laws of the host country and the regulations of the local institution. Neither the U.S. government nor the home institution will be able to secure your release should you be arrested. It is your responsibility to know the drug laws of a foreign country before you go. Some laws may be applied more strictly to foreigners than to local citizens; therefore, do not assume that just because local people are using drugs, it's acceptable for you to use drugs.

Here is what the U.S. Consulate CAN and CANNOT do if you are arrested on drug charges:

The U.S. Consular Office CAN:

- visit you in jail after being notified of your arrest
- give you a list of local attorneys (The U.S. Government cannot assume responsibility for the professional ability or integrity of these individuals or recommend a particular attorney)
- notify your family and/or friends and relay requests for money or other aid but only with your authorization
- intercede with local authorities to make sure that your rights under local laws are fully observed and that you are treated humanely, according to internationally accepted standards
- protest mistreatment or abuse to the appropriate authorities

The U.S. Consular Office **CANNOT**:

- demand your immediate release or get you out of jail or the country
- represent you at trial or give legal counsel
- pay legal fees and/or fines with U.S. government funds

If you are caught using illegal drugs by a BLV program leader, you will be immediately dismissed from the service program. You will be sent home at your own expense. If you are caught by local authorities, it could mean:

- interrogation and delays before trial, including mistreatment and solitary confinement for up to one year under very primitive conditions
- lengthy trials conducted in a foreign language, with delays and postponements



DRUG AND ALCOHOL POLICIES (3 OF 3)

- weeks, months or life in prison (some places include hard labor, heavy fines, and/or lashings), if found guilty
- death penalty in a growing number of countries (e.g., Malaysia, Pakistan, and Turkey)

Although drug laws vary from country to country, it is important to realize before you make the mistake of getting involved with drugs that foreign countries do not react lightly to drug offenders. In some countries, anyone who is caught with even a very small quantity for personal use may be tried and receive the same sentence as the large-scale trafficker.

- Once you leave the United States you are not covered by U.S. laws and constitutional rights.
- Bail is not granted in many countries when drugs are involved.

The burden of proof in many countries is on the accused to prove his/her innocence.

- In some countries, evidence obtained illegally by local authorities may be admissible in court.
- Few countries offer drug offenders jury trials or even require the prisoner's presence at trial.
- Many countries have mandatory prison sentences of seven years to life without the possibility of parole.

I have read these Alcohol and Drug Policies and agree to comply and support these regulations with full understanding that disciplinary actions will be made against me should I choose to violate this contract including possible dismissal from the program including required immediate return home at my own cost; academic withdrawal from the college for the semester in progress; and disciplinary action upon return to campus/school. I have been informed of the possible hazards and legal consequences of alcohol and drug consumption and the tendency for some students to engage in such behavior during international or domestic academic traveling programs.

Additionally, there is an unknown amount of inherent risk in horse riding during the programs.

LIABILITY WAIVER / RISK ACKNOWLEDGEMENT / RELEASE / INDEMNITY/ PARENTAL CONSENT

I/my child understand that participation in horse riding during the program could involve risk of physical injury, illness, death or property loss, including, but not limited to, the risks listed herein.

In consideration of the option to participate in horse riding, with full knowledge that there is risk involved in horse riding, and in acceptance of all risks associated with horse riding during the trip; and with full understanding of the above issues/conditions and risks, I/my child hereby waive, release, indemnify and hold harmless Bright Light Volunteers, its staff, employees, officers, volunteers, and agents from any and all form and manner and type of risks inherent in horse riding during the trip, and release, indemnify and hold harmless Bright Light Volunteers from all liability from all claims, suits and demands of any nature arising from horse riding during the trip, and this agreement is subject to mandatory arbitration in Dallas, Texas.

By your signature on this form, you and/or your parent consent and opt to participate in horse riding during the program, and agree to the all of the words and provisions of this document.

Some of the inherent risks of horse riding, include, but are not limited to, the following:

- a. Bites, kicks, abrasions or contusions from horses;
- b. Scratches or other injury from stalls, enclosures, or other objects, devices, or equipment;
- c. Allergic reactions to animals, hay, or other allergens;
- d. Tripping in holes or on materials or equipment;
- e. Slipping, falling, or otherwise being injured on the ground, which can be slippery, muddy, wet, or contain other hazards.

I/we hereby specifically forever waive and release Bright Light Volunteers International, and all its principals and agents from any liability for injury arising out of riding horses, working with horses, participating in activities with horses during the program.



By signing this agreement, I/we acknowledge that there will be no nurse nor medical personnel present while the horse riding activities occur, and I consent to same

I/we agree to indemnify, save and hold harmless Bright Light Volunteers International and its principals and agents from and against any and all loss, liability, damage, attorney fees, and costs that I may incur arising out of, or in any way connected with, my presence or riding of horses during my program.

By signing this Agreement, I/we hereby acknowledge my complete understanding, agreement, and consent to riding horses, presence with horses, and participating in any and all activities with horses, while participating in a service project with Bright Light Volunteers international, and I/we fully agree to this Agreement and all its words, clauses, paragraphs, terms of the disclosures, waivers, releases, and indemnities contained herein.

If I/we are present at and participate in any activity in any way associated with horse riding and/or horses, I/we do so at our own risk, and I/we hereby acknowledge and agree that Bright Light Volunteers, and/or its principals, agents, staff shall have no responsibility or risk arising from such participation in such activities. I/we have signed this agreement with full understanding and agreement to all of the foregoing.

GST 140 GLOBAL SERVICE LEARNING AND CITIZENSHIP EARNING COLLEGE CREDIT AND/OR A CERTIFICATE OF GLOBAL CITIZENSHIP

Bright Light Volunteers, in partnership with Bethel University, uses a methodology called 'global service-learning' which combines international community service with experiential and online learning. This approach has proven to create culturally aware, global leaders and citizens who understand their place in the world and their ability to effect change both at home and abroad. On post-GSLC surveys, 100% of our high school participants report that they have a deeper knowledge of the interconnections between the United States and the rest of the world. They also report having a better understanding of and appreciation for other people and cultures as a result of their GSLC experience. Through this innovative program, participants will:

- Enroll in a five week, online course, GST 140 Global Service Learning and Citizenship (GSLC), through Bethel University, for three, transferable, credit hours. With guidance from UNESCO global citizenship education, the GSLC course equips participants with the broad knowledge and functional skills necessary to become culturally competent, global citizens and leaders. Via the online course, participants gain exposure to the history and culture of the host country, preparing them well for the experience of cultural immersion and exchange. Participants improve their understanding and critical thinking about global issues and the interconnectedness of different countries and populations. They become familiar with UN Global Goals and develop an understanding of how their service supports the development of a more peaceful and sustainable world.
- In addition to the online course work, in-country lectures, small group discussions, and
 reflection activities are implemented to facilitate deep learning among our participants.
 Reflective activities include focused journaling and discussions with trained BLV/BU staff about
 program projects, accomplishments, challenges, cultural differences, community impact,
 sustainability issues, and personal/professional growth.
- The cost of tuition for the course is included in the program donation. However, there is a separate enrollment process (see information on the following pages)

I, the person signing this Release Agreement, now voluntarily enter into this Release Agreement ("Release") with Bethel University.

required to complete any degree program at Bethel University.		

In order for Bethel University to permit me to participate in the Program, Bethel University requires that I enter into this Agreement. In consideration of Bethel University allowing me to participate in the Program, which I agree is full and adequate consideration, I now enter into this Release Agreement, fully intending that I will be legally bound by it.

I now agree on behalf of myself and my heirs, assigns, personal representative, and estate to expressly release and defend, discharge, and indemnify Bethel University (its employees, officers, directors, agents, board members, volunteers, affiliates, subsidiaries and assigns) for any personal injury or property damage related to or occurring as the result of my participation in the Program, or while traveling to and from the Program site. I further represent that I am 18 years of age or older, have the authority to execute this Agreement, and that I am not under guardianship, conservatorship or any other legal authority.

I recognize that the Program involves risks, both known and inherent risks and unknown or unanticipated risks. My participation in the Program could result in damage to or loss of my personal property and serious physical or emotional injury to me, up to and including death. These risks include but are not limited to risks involved in air and ground transportation, differences in living conditions, diet, water quality, pollution, climate, political stability, and crime control. I will experience a different cultural environment while traveling in the course of the Program, which may include different cultural stereotypes or expectations, sexual harassment, or other uncomfortable situations. While representatives of Bethel University will make reasonable efforts under the circumstances to respond to any of my health care and personal safety needs, I understand that any care or protection provided may differ significantly from care or protection available in the United States.
